CULTURAL CENTER OF THE PHILIPPINES (CCP) MAIN BUILDING RAMP STRUCTURAL RETROFITTING

1. The Cultural Center of the Philippines (CCP), through its Corporate Operating Budget of 2019 intends to apply the sum of *Twelve Million Eight Hundred Forty Eight Thousand Two Hundred Fifty Pesos and 52/100 only (Php12,848,250.52)*, VAT Inclusive, being the Approved Budget for the Contract (ABC) to payments under the contract for the project “*Cultural Center of the Philippines (CCP) Main Building Ramp Structural Retrofitting*” Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Cultural Center of the Philippines* now invites bids for the “*Cultural Center of the Philippines (CCP) Main Building Ramp Structural Retrofitting*”. The contract duration shall be one hundred fifty (150) calendar days excluding holidays or unworkable days due to disasters, severe weather conditions or similar extreme circumstances as may be mutually agreed upon in writing by the CCP and the CONTRACTOR. The work shall start upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the project with at least fifty percent (50%) of the ABC. Bidders should have been in business operation in the field of structural retrofitting and similar project for at least five (5) years. Bidders should have a valid Philippine Contractors Accreditation Board (PCAB) License with minimum license category small "B". The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least sixty (60) percent interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to commonwealth Act 138.
4. Interested bidders may obtain further information from the Cultural Center of the Philippines and inspect the Bidding Documents at the address given below every Tuesdays to Fridays 9:00am – 5:00pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting February 20, 2020 from the address below and upon payment of a non refundable fee for

the Bidding Documents in the amount of Twenty Five Thousand Pesos only (Php25,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The CCP will hold a Pre-Bid Conference on **February 27, 2020, 3:00pm** at the **CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City** which shall be open to all prospective bidders.

7. Bids must be delivered to the address below on or before **March 12, 2020, 2:00pm** at the **CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall be on **February March 12, 2020, 2:00pm** at the **CCP Boardroom 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address stated herein. Late bids shall not be accepted.

8. The Cultural Center of the Philippines reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
