



INVITATION TO BID

RETROFITTING OF ELECTRICAL WIRING AT CCP MAIN BUILDING PHASE-I (REPLACEMENT OF ELECTRICAL PANEL BOARD)

1. The *Cultural Center of the Philippines (CCP)*, through its *Corporate Operating Budget* of 2019 intends to apply the sum of **Fourteen Million Ninety Eight Thousand Eight Hundred Seventy Four Pesos & 70/100 (Php14,098,874.70)**, Inclusive of VAT and all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the **“Retrofitting of Electrical Wiring at CCP Main Building Phase-I (Replacement of Electrical Panel Board)”** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Cultural Center of the Philippines* now invites bids for the **“Retrofitting of Electrical Wiring at CCP Main Building Phase-I (Replacement of Electrical Panel Board)”**. The duration of the project shall be within One Hundred Eighty (180) calendar days, excluding holidays or unworkable days due to disasters, and severe weather conditions or similar circumstances, as may be mutually agreed upon by the CCP and the CONTRACTOR. The work shall start upon receipt of Notice to Proceed. The CONTRACTOR should have been in legal operation in the field of retrofitting of electrical panel board with a capacity similar to the requirements stated in the Terms of Reference (TOR) for at least five (5) years. The CONTRACTOR should have its own specialized technical personnel (Professional Electrical Engineer (PEE) or Registered Electrical Engineer (REE). The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least sixty (60) percent interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to commonwealth Act 138.
4. Interested bidders may obtain further information from the *Cultural Center of the Philippines* and inspect the Bidding Documents at the address given below every Tuesdays to Fridays 9:00am – 5:00pm.

5. A complete set of Bidding Documents may be purchased by interested Bidders starting October 30, 2019 from the address below and upon payment of a non refundable fee for the Bidding Documents in the amount of *Twenty Five Thousand Pesos only (Php25,000.00)*.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The CCP will hold a Pre-Bid Conference on November 5, 2019, 2:00pm at the *CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City* which shall be open to all prospective bidders.
7. Bids must be delivered to the address below on or before November 19, 2019, 2:00pm at the *CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall be on November 19, 2019, 2:00pm at the *CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address stated herein. Late bids shall not be accepted.

8. The Cultural Center of the Philippines reserves the right to accept or reject any bid, to reject all bids, to annul the bidding process at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
