INVITATION TO BID

**SUPPLY AND INSTALLATION OF THREE (3) BRAND NEW UNITS OIL
TYPE TRANSFORMER AND ONE (1) BRAND NEW UNIT DRY TYPE
TRANSFORMER
(2ND POSTING)**

1. The *Cultural Center of the Philippines (CCP)*, through its *Corporate Operating Budget* of 2018 intends to apply the sum of *Four Million Three Hundred Eighty One Thousand One Hundred Eighty Pesos (Php4,381,180.00)*, Inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the **“Supply and Installation of Three (3) Brand New Units Oil Type Transformer and One (1) Brand New Unit Dry Type Transformer”** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Cultural Center of the Philippines* now invites bids for the **“Supply and Installation of Three (3) Brand New Units Oil Type Transformer and One (1) Brand New Unit Dry Type Transformer”**. The duration of the project shall be one hundred twenty (120) calendar days excluding holidays or unworkable days due to disasters, severe weather conditions or similar extreme circumstances, as may be mutually agreed upon in writing by the CCP and the CONTRACTOR. The work shall start upon receipt of Notice to Proceed. Bidder should have been in legal operation in the field of supply and installation of brand new transformer with a capacity similar to the requirements stated in the Term of Reference (TOR) for at least five (5) years. The bidder must submit a copy of Certificate as authorized reseller/supplier/distributor/installer from the manufacturer of the item being offered. The bidder must submit at least three (3) certificates of "Satisfactory Performance" from its previous clients. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least sixty (60) percent interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to commonwealth Act 138.

4. Interested bidders may obtain further information from the *Cultural Center of the Philippines* and inspect the Bidding Documents at the address given below every Tuesdays to Fridays 9:00am – 5:00pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting April 4, 2019 from the address below and upon payment of a non refundable fee for the Bidding Documents in the amount of *Five Thousand Pesos Only (Php5,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The CCP will hold a Pre-Bid Conference on April 11, 2019, 2:00pm at the *CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City* which shall be open to all prospective bidders.
7. Bids must be delivered to the address below on or before April 25, 2019, 2:00pm at the *CCP Boardroom, 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall be on April 25, 2019, 2:00pm at the *CCP Boardroom 3/F Tanghalang Pambansa, CCP Complex, Roxas Boulevard, Pasay City*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address stated herein. Late bids shall not be accepted.

8. The Cultural Center of the Philippines reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
